

POLICIES AND LEGISLATIONS

DOH-Administrative Order 2006-0016

- Known as the "National Policy and Strategic Framework on Child Injury and Prevention" in June, 2006.
- Priority areas are road traffic injuries, drowning, falls, burns and poisoning.
- National Safe Kids Week (NSKW)- every 3rd week of June with Presidential Proclamation No. 1307
- Philippine Road Safety Action Plan 2017-2022
- R.A. 10666 Children's Safety on Motorcycles Act of 2015
- R.A. 11229 Children's Safety on Motorcycles Act of 2019







- Road Safety Education to children through the Walk This Way Program (pedestrian safety program)
- Safe School Zone -School Rating for Schools and improving the walking environments of the schools
- International Walk to School Week (IWTSW)-every October reminding the children to be safe while walking to and from school
- World Day of Remembrance (November)
- Child Road Traffic Injury Prevention (CRTIP) Program










Organizing, building and capacitating the stakeholders. As we say, our work on road safety should be multisectoral. One agency cannot do it alone.

Laws on child's road safety





R.A. 10666 Children's Safety on Motorcycles Act of 2015 (signed on May 15, 2015).

Children are prohibited to ride on motorcycles without the use of helmets.

CHILD SAFETY IN MOTOR VEHICLES ACT 2021 (RA 11229)

It requires the use of car seats when transporting children and the use of appropriate child restraint based on height and weight.

It prohibits children 12 years old and below to sit infront of the private vehicles especially if shorter than 4'11 inches.



ROAD SAFETY TIPS TO SAVE THE LIVES OF CHILDREN FROM ROAD TRAFFIC CRASHES

- 1. Teach the kids to look left, right and left again before crossing the street.
- 2. Teach kids not to use their phones, headphones, and devices when crossing the street. We have to reinforce this message with teenagers.
- 3. Always follow the traffic laws. Respect the traffic enforcers.
- 4. Children under 10 years old should always supervise by adults while on the road.

ROAD SAFETY TIPS TO SAVE THE LIVES OF CHILDREN FROM ROAD TRAFFIC CRASHES

5. To use the appropriate and standard child car seats for every child.

6. To use the standard helmets when children are riding motorcycles.

7. Be a role model.


